A BILL

Be it enacted by the Senate and House of Representatives of the United States in Congress Assembled.

SEC. 1—SHORT TITLE

(a) This piece of legislation shall be referred to as "
"Federal Budget Allocation Act of Fall
2024"

SEC. 2 — <u>APPROPRIATIONS.</u>

There are hereby appropriated, out of R\$ (robux) 40,000 in the Treasury not otherwise appropriated, for the fiscal term ending November 22, 2024, the following sums for the specified departments and agencies to use for the duration of the term:

- (a) DEPARTMENT OF JUSTICE.—For the Department of Justice, R\$ 6,500.
 - (i) Tryout Center Development: R\$ 2,500
 - (ii) Recruitment Graphics: R\$ 2,000
 - (iii) Moot Court Competition: R\$ 2,000

- (b) DEPARTMENT OF HOMELAND SECURITY.—For the Department of Homeland Security: R\$ 4,000.
 - (i) United States Secret Service: No funds are appropriated for the United States Secret Service.
 - (ii) Federal Protective Service: R\$ 2,000 (1) Recruitment Graphics: R\$ 2,000
 - (iii) United States Coast Guard: R\$ 2,000 (1) Recruitment Graphics: R\$ 2,000
- (c) DEPARTMENT OF TRANSPORTATION.—For the Department of Transportation, R\$ 3,000.
 - (i) Recruitment Graphics: R\$ 1,900.
 - (ii) Advertiser Gamepass (x4): R\$ 1,100.
- (d) DEPARTMENT OF STATE.—For the Department of State, R\$ 10,000.
 - (i) Embassy Development: R\$ 5,000.
 - (ii) Foreign Aid: R\$ 4,000.
 - (iii) Diplomatic Security Service: R\$ 1,000 (1) New Uniforms: \$1,000
- (e) DEPARTMENT OF COMMERCE AND LABOR.—For the Department of Commerce and Labor, R\$ 3,000.
 - (i) Business Funding: R\$ 3,000. The appropriated funds must be distributed to no less than six separate businesses.
- (f) EXECUTIVE OFFICE OF THE PRESIDENT.—For the White House and related executive offices, R\$ 4,500.
 - (i) Graphics: R\$ 4,500.
- (g) DEPARTMENT OF DEFENSE.—For the Department of Defense, R\$ 1,000.
 - (i) Defense Force Protection Agency: R\$ 500 (1) Recruitment Graphics: R\$ 500.
 - (ii) National Guard Bureau: R\$ 500 (1) Recruitment Graphics: R\$ 500.

- (h) NATIONAL AERONAUTICS AND SPACE ADMINISTRATION.—For the National Aeronautics and Space Administration, R\$ 2,000.
 - (i) Recruitment Graphics: R\$ 2,000
- (i) DEPARTMENT OF THE TREASURY.—For the Department of the Treasury, R\$ 1,000.
 - (i) Financial Crimes Enforcement Network: R\$ 1.000
 - (1) Recruitment Graphics: R\$ 1,000
- (j) INTELLIGENCE COMMUNITY.—No funds are appropriated for the Intelligence Community.
- (k) DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT.—No funds are appropriated for the Department of Housing and Urban Development.
- (l) LEGISLATIVE BRANCH.—No funds are appropriated for the Legislative Branch.
- (m) SPECIAL WEAPONS AND TACTICS.—No funds are appropriated for Special Weapons and Tactics units under this Act
- (n) SPECIAL FORCES.—No funds are appropriated for Special Forces units under this Act

SEC. 3 — <u>EXECUTIVE DISCRETION IN</u> <u>FUND DISTRIBUTION.</u>

- (a) AUTHORITY.—Notwithstanding any other provision of this Act, the President of the United States may redistribute funds allocated to federal agencies and departments as specified in Section 2 of this Act.
- (b) LIMITATIONS.—
 - (i) The total amount of funds redistributed shall not exceed 50% of an executive department or

- agency's original allocation as specified in Section 2 of this Act.
- (ii) Any redistribution of funds exceeding 10% of an agency or department's original allocation as specified in Section 2 of this Act shall require written notification explaining the reason(s) for the redistribution to the Speaker of the House and Minority Leader of the United States House of Representatives, Majority and Minority Leader of the United States Senate, and the respective agency head(s) to which such funds shall be taken and given thereto.
- (iii) The President shall submit a report to Congress detailing any redistributions made under this authority within 72 hours.

SEC. 4 — <u>AGENCY EXPENSE REPORTING.</u>

- (a) REQUIREMENT.—The head of each department or agency receiving funds under this Act shall submit a detailed report of all expenses to Congress within 72 hours of incurring such expenses.
- (b) CONTENT OF REPORT.—Each report submitted under subsection (a) shall include:
 - (i) A itemized list of all expenses incurred;
 - (ii) The date and time each expense was incurred;
 - (iii) The purpose of each expense;
 - (iv) The name and title of the official authorizing each expense;
 - (v) The remaining balance of the agency's allocated funds after accounting for the reported expenses.
- (c) SUBMISSION PROCESS.—Reports shall be submitted electronically to the following:
 - (i) Speaker of the House
 - (ii) Minority Leader of the United States House of Representatives

- (iii) Majority Leader of the United States Senate
- (iv) Minority Leader of the United States Senate,
- (d) PUBLIC DISCLOSURE.—A summary of each report, excluding any classified or sensitive information, shall be made available to the public on the respective agency's official website within 7 days of submission to Congress.
