Arthur_Chen of the Commonwealth of Virginia (for himself, AdremiCross of the State of Illinois) introduced the following bill; which was referred to the Committee on Governmental Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concern

A BILL

Be it enacted by the Senate and House of Representatives of the United States in Congress Assembled.

SEC. 1—SHORT TITLE

(a) This piece of legislation shall be referred to as *"Technozo Congressional Gold Medal Act"*

SEC. 2 — <u>FINDINGS</u>

The Congress find the following:

- (a) Technozo has served the United States with distinction in the highest levels of our community and government. Throughout his career, Technozo has contributed significantly to the political and legal communities, inspiring a new generation of leaders through his dedicated public service.
- (b) In February 2020, Technozo was elected Vice President of the United States along with Reset4k in the Winter 2020 election. Technozo ascended to the presidency in June 2020,

becoming the 31st President of the United States and serving until July 2020.

- (c) He has held numerous influential positions in congress, including Representative, Senator, and Senate Majority Leader.
- (d) Technozo further expanded his service to the nation as Secretary of Transportation, working to bring a long-forgotten department back to the forefront of the community.
- (e) Technozo additionally served as a clan manager in 2018, assisting with the group's management and internal operations.
- (f) In July 2024, Technozo served as Speaker of the House, leading the chamber to once again do the people's work after long periods of inactivity.
- (g) From August 2024 to October 2024, Technozo served as an Associate Justice of the Supreme Court, bringing his extensive experience in governance to the judicial branch.
- (h) On October 7, 2024, Technozo announced his retirement from the Supreme Court and public service effective October 9, 2024, marking the end of a distinguished career that has significantly impacted the community and all three branches of our government.
- (i) Technozo's lifetime of selfless service to the United States and the greater nUSA community deserves nothing short of the highest recognition by the congress and the thanks of every American.

SEC. 3 — <u>CONGRESSIONAL GOLD MEDAL</u>

(a) The Speaker of the House of Representatives and the President pro tempore of the Senate shall make appropriate arrangements for the presentation, on behalf of the Congress, of a gold medal of appropriate design to Technozo for his lifetime of selfless service to the United States.

- (b) Design And Striking.—For the purposes of the presentation referred to in subsection (a), the Secretary of the Treasury (hereafter in this Act referred to as the "Secretary") shall strike gold medals with suitable emblems, devices, and inscriptions, to be determined by the Secretary.
- (c) Disposition Of Medals.—Following the award of the gold medal under subsection (a):

(1) TECHNOZO.— One gold medal shall be given to Technozo.

SEC. 4 — <u>STATUS OF MEDALS</u>

- (a) National Medals.—The medals struck pursuant to this Act are national medals for purposes of chapter 51 of title 31, United States Code.
- (b) Numismatic Items.—For purposes of section 5134 of title 31, United States Code, all medals struck under this Act shall be considered to be numismatic items.

SEC. 5 — <u>FINANCIAL ASSURANCES</u>

(a) The Secretary of the Treasury shall take such actions as may be necessary to ensure that the minting and issuing of coins under this Act will not result in any net cost to the United States Government.
