To allow municipal and federal employees to commit crime while on the “American Citizen” team without the risk of Termination from government or municipal agencies or departments.

AN ACT

To allow municipal and federal employees to commit crime while on the “American Citizen” team without the risk of Termination from government or municipal agencies or departments.

*Be it enacted by the Senate and House of Representatives
of the United States in Congress Assembled.*

SEC. 1—SHORT TITLE

- (a) This piece of legislation shall be referred to as ***“H. R. 48”*** or as ***“Public Servant Freedom Act of 2024”***

SEC. 2—GENERAL PROVISIONS

- (a) Any part of any act, joint resolution, memorandum or codified law that conflicts with this act shall be deemed null and void.
- (b) This act shall be servable, in which, if any provision of this act is found unconstitutional the rest of the act shall be in full effect unless also found unconstitutional.
- (c) This act shall go into effect immediately.

SEC. 3 EMPLOYEE RIGHTS

- (a) All workers or employees of federal agencies and or departments shall have the right to commit crimes on the “American Citizens” team.
- (b) All workers or employees of federal agencies and or departments shall have the right to file suit for False Termination if terminated for “Off Team Crime” if the department or agency does not have a policy regarding it.

SEC. 4 RESTRICTIONS

- (a) All workers and employees may not commit crimes off team then switch teams and arrest any individual that they conspired, assisted, or witnessed committing a crime that while on the “American Citizens” team unless in an intelligence or undercover form.

- (b) Individuals that hold any position that is appointed by the President of the United States branch may not commit crimes off team unless a special event is being hosted or a pardon from the President or Vice President of the United States. This does not include members of Congress and or department Directors.
- (c) Individuals that engage in off team crime cannot target departments that they are employed in. Individuals that do not follow this are subject to termination.

SEC. 5 POLICIES AND PROCEEDINGS

- (a) Agency oversight may develop a policy regarding off team criminal behavior, but it is not obligatory to implement one restricting it.
- (b) Individuals that commit crimes are still subject to being charged or tried with crimes that they commit while on the “American Citizens” team but cannot be fired or terminated from their employer for “off team crime”.
