Representative GhillieTactical from the great state of Michigan has introduced the following bill, which shall be read on the House floor and referred to the appropriate committee.

AN ACT

To enhance transparency between the United States
Military and Congress.

*Be it enacted by the Senate and House of Representatives
of the United States in Congress Assembled.*

SEC. 1—SHORT TITLE

- (a) This piece of legislation shall be referred to as “**H. R. 68**” or as “**USM Transparency Act (UTA)**”

SEC. 2—GENERAL PROVISIONS

- (a) Any part of any act, joint resolution, memorandum or codified law that conflicts with this act shall be deemed null and void.
- (b) This act shall be servable, in which, if any provision of this act is found unconstitutional the rest of the act shall be in full effect unless also found unconstitutional.
- (c) This act shall go into effect immediately.

SEC. 3 REASONING

- (a) This act allows better internal relationships between the United States Military and the US Congress.
- (b) This bill aims to allow congress to understand military readiness and progress being made within our 5 branches.
- (c) All branches will be subject to this bill and all of the requirements listed in the follow-up section.
- (d) The enactment of this bill is so congress is more involved with military leadership.

SEC. 4 REQUIREMENTS

- (a) The requirements for transparency to be in order is a joint meeting monthly, in the (3) week of every month (date at discretion) with our Joint Chiefs of Staff to discuss military preparedness.
- (b) All Joint Chiefs of Staff and Vice Joint Chiefs of Staff are required to attend.
- (c) Joint Staff is required to attend as well, at all meetings as they are designated as senior USM personnel.
- (d) The goal is to discuss military preparedness, all Joint Staff, Joint Chief of Staffs, and the Chairman and Vice Chairman of the Joint

Chiefs, are required in attendance with congress to discuss military preparedness.

SEC. 5 COMMITTEES

- (a) The Senate Armed Services Committee as well as the House Armed Services Committee will oversee the meeting with the senior USM personnel and oversee the proceedings.
- (b) They will meet with each committee individually and discuss military matters with them, as well as any concerns they may have.

SEC. 6 EXCEPTIONS

- (a) If a Joint Staff or any other Senior member of USM is able to attend they are asked to send their Senior Enlisted Advisor to cover them at the proceedings.
- (b) The specific date and time can be made and agreed upon by all parties if there's a conflict.

SEC. 7 ENACTMENT

- (a) This will go into effect the moment it's signed and approved.
